The following people are defined as having parental responsibility:

Birth mothers. Birth fathers married to the child's mother at the time of birth. Unmarried fathers who subsequently marry the birth mother. From 1st December 2003 unmarried fathers have parental responsibility where he and the mother together register the birth of their child. Parental responsibility can also be granted via a successful application to the court, through a parental responsibility agreement, through a residence order or a special guardianship order.
